POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 21 AUGUST 2017

At the annual general meeting of Man King Holdings Limited (the “**Company**”) held on 21 August 2017 (the “**AGM**”), all the proposed resolutions (the “**Resolutions**”) as set out in the circular (the “**Circular**”) incorporating the notice of the AGM dated 20 July 2017 were voted by way of poll. The board (the “**Board**”) of directors (the “**Directors**”) of the Company is pleased to announce that all the Resolutions were duly passed as ordinary resolutions at the AGM by the shareholders of the Company (the “**Shareholders**”) through voting by way of poll. Unless otherwise defined, terms used herein shall have the same meaning as defined in the Circular.

The poll results in respect of all the Resolutions at the AGM are set out as follows:

As more than 50% of the votes were cast in favour of each of the Resolutions, all of them were duly passed as ordinary resolutions at the AGM.

As at the date of the AGM, the total number of shares of the Company in issue was 420,502,000 shares, which was the total number of shares of the Company entitling the holders thereof to attend and vote on the Resolutions at the AGM. No Shareholders were entitled to attend and were required under the Rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (“**Listing Rules**”) to abstain from voting in favour on any of the resolutions at the AGM and no Shareholders were required under the Listing Rules to abstain from voting on any of the resolutions at the AGM.

In addition, no Shareholders have stated their intention in the Circular to vote against or to abstain from voting any of the Resolutions at the AGM.

Tricor Investor Services Limited, the Company's branch share registrar in Hong Kong, was appointed by the Company as scrutineer for vote-taking at the AGM.
